Many hotels are active partners in conserving energy and creating a sustainable future. Accor, which operates 4,000 hotels in 90 countries, enacted a measure in 2008 entitled "5 towels re-used = 1 tree planted" with the goal of using its laundry savings from linen re-use toward planting trees. Thanks to the savings of two years, Accor announced in 2010 that it has financed the planting of 1 million trees.
